



Summary of Agreements

My organization will comply with the Heads Up Football® Membership Terms and Conditions, which specifically include-but are not limited to-the following requirements:

1. Nominate a Player Safety Coach (PSC) that will become Level 1 Coach Certified in 2015
2. PSC will attend a one-day, in-person USA Football PSC Clinic in 2015
3. Maintain and provide proof of insurance that meets USA Football's requirements
 - \$1 Million General Liability
 - \$25,000 Accident and Health/Participant Accident
 - Add Heads Up Football, LLC as an additional insured
4. Require all coaches become USA Football coach members (\$10/coach) and complete Level 1 Coach Certification or Recertification
5. Conduct a Heads Up Coaches Clinic for all head coaches led by PSC and a Heads Up Parents Safety Meeting led by PSC and/or head coaches
6. Require parents/guardians sign release of liability waivers naming USA Football and Heads Up Football, LLC as released parties





You and your organization's Player Safety Coach can visit the Player Safety Dashboard at any time to track your organization's and access football and health and safety resources




